

ENTRY FORM: 11th Annual Community Artist Showcase, Oct. 1—Nov. 12

This is a Juried Showcase with **Best in Show** awards for Fine Art, Photography, and Sculpture/Jewelry/3-D work.

THE TERMS:

- ◆ Artist must be 18 years or older and reside within 40 miles of Fairfield, OH.
- ◆ Artist may submit up to three (3) works.
- ◆ All entries must be the complete and original work of the submitting artist and completed within the last five (5) years. Photographs should be the sole composition of the artist,
- ◆ such that no other individual has creative input, including computerized enhancements.
- ◆ All styles of 2D artwork are eligible, including paintings, drawings, prints, screens, and photography. Entries exceeding 48-inches, either height or width including framing, must seek prior approval.
- ◆ All hanging works must be ready to install with display devices that are appropriate to the size and weight of the piece, not to exceed 100lbs.
- ◆ All styles of pottery, sculpture and jewelry are eligible, including large floor pieces. Entries intended for closed display cases should not exceed 23-inches in height.

THE CONDITIONS:

- ◆ Entry in this selection process does not guarantee inclusion in the Community Artist Showcase.
- ◆ Fairfield Community Arts Center and the City of Fairfield are not responsible for any loss or damage during delivery or pick-up. Selected works are insured for a reasonable amount for the duration of the selection process, installation, and exhibit.
- ◆ Fairfield Community Arts Center reserves the right to reproduce the work for purposes of publicity, marketing, education, and archival records, now and in the future, as related to the Community Artist Showcase.

THE JURORS: All works will be selected for the Community Artist Showcase by the City of Fairfield Cultural Arts Advisory Committee and by the Arts & Programs Manager / Fairfield Community Arts Center Manager.

PRICING: *The Fairfield Community Arts Center retains a 10% commission for all Art Gallery sales. All published pricing for each work will be determined from the Entry Label for each work. If no sale price or insured value is provided by the artist, the Fairfield Community Arts Center will automatically assign a \$100 insurance value to the entry and it will be listed at NFS, Not For Sale.*
