
Narrative

On April 08, 2016 Unit 1 was southbound on Dixie Highway. Unit 2 was turning left (northbound) from Commercial Dr. onto Dixie Highway. Unit 1 was struck by Unit 2.

Unit 1 was unsure of his travel direction, lane of travel, or traffic light color. He believed he was traveling southbound, attempting to make a left turn onto Commercial Dr. to turn around, and head back northbound.

The driver of Unit 2 advised the eastbound traffic light turned green, he pulled into the intersection, Unit 1 ran the red southbound traffic light, and Unit 2 struck the passenger-side front of Unit 1. He advised Unit 1 was traveling in the inside thru lane.

Unit 1 was issued a citation for Failure to Obey Traffic Control Device.
