

Narrative

On 4/9/16 at about 1:45 a.m. Unit was traveling north on Dixie Hwy and when at Woodridge Blvd apparently lost control for unknown reasons and collided with Unit 2 which was parked at the traffic light in the left turn lane waiting to turn. Brake lights were inspected on Unit 2 and were working properly.

Unit 2 is a semi which was pulling a trailer with trailer license plate OK 8785HA. The trailer is owned by Sygma Network trailer number 242044.


