

Narrative

On 04-11-16 at 6:33 a.m., Unit 1 and Unit 3 were traveling east on Nilles Rd in the right hand right turn lane. Unit 2 was traveling east on Nilles Rd. in the left hand right turn lane. Unit 1 and Unit 2 made a right turn. Unit 1 made the turn too wide and struck Unit 2 in the passenger side. This caused Unit 2 to go in to the right hand lane of SR4 (Dixie Hwy) and strike Unit 3 in the driver side front.


