

Narrative

On 04/11/16 at approximately 6:00 a.m. unit 1 was southbound on Dixie Hwy. in the curb lane without any lighted lights. Unit 2 was southbound on Dixie Hwy. in the curb lane behind unit 1. Unit 3 was southbound on Dixie Hwy. in the left lane. The driver of unit 2 did not see unit 1 until he was extremely close and swerved left to avoid unit 1. Unit 2 struck unit 3. Both units spun 360 degrees and unit 3 went off the right side of the roadway striking the curb and causing lawn damage. Unit 1 left the scene. The drivers of unit 2 and 3 confirmed that unit 1 did not have lighted lights.
