

**Narrative**

On April 13, 2016 at approximately 4:06 PM, Unit 2 was traveling Southbound on Winton Rd.; starting to drive forward from being stopped in traffic. Unit 1, also traveling Southbound on Winton Rd. was also just pulling forward from a stopped position and struck the rear bumper of Unit 2. According to the driver of Unit 2 there was already damage to the bumper of his vehicle and it was not clear if any damage occurred during the accident today. There was no damage to Unit 1. Both parties stated that they were traveling less than 5 mph.
