

Narrative

On April 21, 2016 at about 4:00 p.m. Unit 1 was traveling north on S.R.4 (Dixie Hwy.) and when at 5072 Dixie Hwy. went off the right side of the roadway and collided with Unit 2. Unit 2 was then pushed into Unit 3. When Unit 1 was attempting to leave the scene, he struck Unit 4.

The driver of Unit 1 was also cited for OVI, 333.01(a)(1)(A), and 333.01(a)(1)(D).


