

Narrative

On 04/26/2016 at about 12:15 P.M. unit 1 was traveling southwest on Diversion Dr. at about 15 MPH when it failed to stop within the assured clear distance ahead, and in so doing, collided with unit 2 which was stopped at a red light for Dixie Hwy.

The driver of Unit #2 reported the crash from a different location than where the crash occurred. The driver of Unit #1 was not on the scene when the report was made. We have been unable to make contact with the owner or driver of Unit #1 to complete the information on the report.


