

**Narrative**

On 12-06-16 at around 4:25pm, Unit 1 was northbound on Ross Rd in the right through lane. Unit 2 was also northbound on Ross Rd but in the left through lane. The driver of Unit 1 stated that she began to experience mechanical problems with her vehicle causing her to lose control. Unit 1 swerved into Unit 2 in the intersection. Unit 1 struck Unit 2.
