

Narrative

On 12/9/16 at about 10:20AM unit 1 was traveling south on South Gilmore near the intersection of Omniplex and South Gilmore. Unit 1 changed lanes and struck unit 2 in the rear driver's side fender. When talking with the driver of unit 1 she stated that she was unaware of hitting unit 2 and was unable to give any information on what caused the damage to unit 2 vehicle. The driver of unit 2 stated that the driver of unit 1 changed lanes and struck the side of her vehicle. The damage to the passenger side mirror that was on unit 1 was of a corresponding height to the damage of the rear fender that was on unit 2. Measurements and photos were taken to show the height and nature of the damage on each vehicle.


