

On 12/21/2016 at approximately 6:05 P.M. Unit 1 was traveling westbound on Nilles Rd. at approximately 20 m.p.h. and when 50 feet west of Winton Rd. failed to stop within the assured clear distance ahead and collided with Unit 2 which was also westbound on Nilles Rd. and was stopped in traffic 50 feet west of Winton Rd. Unit 2 then collided with Unit 3 which was also traveling westbound on Nilles Rd. Brake lights on Unit 2 were inspected and were working properly.


