

Narrative

On February 25, 2016 around 10:14 p.m. Unit 1 was traveling westbound on Woodridge Blvd. A deer crossed from south to north in front of Unit 1. Unit 1 swerved to avoid hitting the deer, went off the roadway right, and struck a small tree.
