

Narrative

On January 12, 2016 at approximately 5:43 PM, Units 1 and 2 were traveling Northbound on South Gilmore Rd. Unit 1 was stopped in the inside lane, waiting behind a car to turn onto Parkland Hills Dr. Unit 2 was traveling Northbound, in the outside lane. Unit 1 made an improper lane change and began to enter the lane Unit 2 was in, sideswiping the driver side of Unit 2. Unit 2 then went off the right side of the roadway, striking the curb. There was damage to the right front tire rim of Unit 2.

Unit 1 was also cited for Driving Under Suspension; FCO/ 335.07(A).
