

Narrative

Driver of unit 2 said that she was making a left turn from northbound South Gilmore to westbound Kolb Drive on a green arrow. She was in the right of the two left turn lanes. She said as she was making the turn, unit 2 made a right turn from southbound South Gilmore without stopping. She said unit 1 struck the right rear of her car. There was damage to the right rear fender.

Driver of unit 1 said his car did not make contact with unit 2. The drivers and I did a close examination of unit 1. We could not find damage on the vehicle.

The witness said she was behind unit 2 as it made the turn. She said she saw the vehicles come together.


