

Narrative

On 07-01-16 units #1 and #2 were southbound on Ross Rd. near Dixie Hwy. The driver of unit #1 states that unit #2 was in the right lane which ends and that they collided when that lane ends. The driver of unit #2 states unit #1 was passing him in the center turn lane when the two units collided. The driver of unit #2 called dispatch and stated unit #1 was fleeing the scene. He attempted to keep up but lost sight of it. Sometime later the driver of unit #2 also called and left a disconnected phone number with the dispatcher. Unit #1 was also GOA when we went to meet it. Dispatch called them back on the number which showed up on caller ID and threatened the driver of unit #1 with a warrant if they did not return and was hung up on. Eventually the driver of unit #1 returned and said she left because she did not know what to do. She was charged with leaving the scene.


