

Narrative

On 7/8/16 at about 2:33 a.m. Unit 1 was traveling east on Lake Mead Dr., apparently at an excessive rate of speed, and when at 5671 Lake Mead Dr. lost control and collided with Unit 2 which was parked unoccupied on the right side of the street. Unit 1 continued and struck Unit 3 which was parked unoccupied on th right side of the street directly in front of Unit 2. Unit 1 continued and ran off the right side of roadway in to the yard striking the house at 5671 Lake Mead Dr. before coming to a final rest.

The driver of Unit 1 was cited for failure to control and arrested for OVI.

5671 Lake Mead Dr. is the property of Dan Setterstrom. (513)582-1189




