

**Narrative**

On 07/16/16 at approximately 8:55 a.m. Unit #1 was traveling northbound from a private drive at 563 Nilles Road attempting to turn left onto westbound Nilles Road and in so doing failed to yield the right of way to, and collided with, Unit #2. After the collision, Unit #1 fled the scene westbound on Nilles Road.

The driver of Unit #1 was described as a white male, approximately 40 - 50 years old, with dark hair and a hat.


