

Narrative

On 07/29/2016 at 10:26 p.m. Unit 2 was facing south in the right lane of Ross Rd. at the intersection of Mack Rd. when an unknown driver of Unit 1 failed to come to a stop at the intersection and collided with the rear of Unit 2. After striking Unit 2, the driver of Unit 1 exited the vehicle to check on the driver of Unit 2. Both drivers agreed to pull forward into the driveway of Gilbert Park. Unit 1 did not pull over and continued south on Ross Rd. Unit 2 driver described the two occupants in Unit 1 as white females, 40-50 years old.




