

**Narrative**

On June 6, 2016 at about 11:38 a.m. Unit 1 was traveling northbound on Dixie Highway at approximately 25 m.p.h. and when at Seward failed to stop within the assured clear distance ahead and collided with Unit 2 which was also northbound and was stopped or slowing in traffic at Seward Road. Unit 2 left the scene after the crash. Unit 2 was located a short time later.


