

Narrative

On 06-23-16, unit 1 was northbound in the left through lane of Dixie Highway. Unit 1 veered out of the lane and sideswiped unit 2 which was stopped in the right left turn only lane of Dixie Highway. The driver of unit 1 was stopped at Dixie Highway and Hicks Boulevard and transported to Mercy Fairfield after a diabetic reaction. Due to the medical condition, no citation was issued in this accident.


