

On March 11, 2016 at about 6:50 p.m. Unit 1 was traveling south on North Gilmore Rd. at approximately 35 m.p.h. and when at Symmes Rd. attempted to turn left to travel east on Symmes Rd. and in so doing, failed to yield the right of way to oncoming traffic and collided with Unit 2 which was traveling north on North Gilmore Rd. The driver of Unit 1 then fled the scene on foot.
