Narrative

On 3-15-16 at about 2:40 p.m. Unit 1 was westbound in the parking lot of Bohlke Veneer, 8375 N. Gilmore Rd., when it struck Unit 2 which was parked facing northbound in the lot. Unit 1 then continued westbound, ran through a fence and onto the property of Tedia Company, 2880 Symmes Rd. Unit 1 struck a tank trailer that was parked and not connected to a truck. The operator of Unit 1 stated that the accelerator became stuck on the vehicle.

The trailer is a silver 2006 Polar LIC/ME-2096411 (VIN#1PMS3432X61030187) that is owned by M.C. Tank Transport 10134 Mosteller Ln. West Chester, Ohio 45069 (513-771-8667)

The fence is owned by Bohlke Veneer 8375 N. Gilmore Rd. Fairfield, Ohio 45014 513-874-4400
