

Narrative

On March 23, 2016 at about 1:35 p.m. Unit #1 was traveling northbound on Dixie Highway at approximately 5 m.p.h. and when at 7029 Dixie Highway attempted to change to the middle lane of traffic due to a lane closure and in so doing collided with Unit #2 which was traveling northbound on Dixie Highway in the middle lane at approximately 35 m.p.h. Unit #2 then pushed Unit #1 into Unit #3 which was stopped in traffic in the left lane of travel.

Unit #2 was pulling Ohio trailer TPK 7022.


