

On 05/02/2016 at about 5:50 P.M. Unit 1 was attempting to leave the private parking lot at 5161 Dixie Hw. turning left (north) onto Dixie Hw. and, in doing so, failed to yield the right of way to Unit 1 who was traveling north on Dixie Hw. which caused Unit 1 to crash into Unit 2 approximately 50 ft. south of the intersection with Nilles Rd.


