

Narrative

On 05/07/16 at approximately 11:47 a.m. unit 3 was southbound on Pleasant Ave. and stopped for traffic ahead. Unit 2 was southbound on Pleasant Ave. behind unit 3 and stopped for traffic ahead. Unit 1 was behind unit 2 and failed to stop and struck unit 2 in the rear. The impact forced unit 2 forward and struck unit 3.

Unit 1 was towing a camper owned by the driver of unit 1. The camper damaged the rear of unit 1 and possibly the hitch of the camper.


