

**Narrative**

On 05-09-16 at 7:50 a.m., Unit 2 was traveling east in the center thru lane of Nilles Rd. Unit 1 was stopped in the Speedway (5161 Dixie Hwy: Nilles Rd exit), waiting to turn right onto Nilles Rd. Unit 1 attempted to make his right turn into the left thru lane of Nilles Rd. when Unit 2 changed lanes into the left turn lane. Unit 1 and Unit 2 collided. Damage was on the passenger side of Unit 2 and the front driver's side bumper of Unit 1.
