

Narrative

On 11/07/2016 at about 7:43 A.M. unit 1 was traveling southbound on Dixie Hwy at about 5 MPH when it failed to stop within the assured clear distance ahead, and in so doing, collided with unit 2 which was stopped on traffic on southbound Dixie Hwy.


