

Narrative

On 11-10-16 at about 3:40 PM Unit 1 was traveling Southbound on S.R. 4 (Dixie Hwy) at approximately 10 m.p.h. and when at Woodridge Blvd. attempted to turn left to travel Eastbound and in so doing, failed to yield the right of way to oncoming traffic and collided with Unit 2 which was traveling Northbound on S.R. 4 (Dixie Hwy). With traffic coming to a halt, Unit 3 struck the rear of Unit 1, who was directly behind Unit 1.


