

Narrative

On 11-29-16 at 7:52 a.m., Unit 1 was traveling southbound on SR4 (Dixie Hwy) in the left thru lane. Unit 3 was traveling southbound on SR4 (Dixie Hwy) in the left turn lane. Both Unit 2 and Unit 4 were stopped in traffic southbound on SR4 (Dixie Hwy) in the left thru lane. Unit 1 drove into the driver side rear of Unit 2 causing Unit 2 to strike Unit 4. Unit 1 then struck the passenger side of Unit 3. The driver of Unit 1 left the scene without exchanging information with the other drivers involved and before police arrived.
