

Narrative

On 11-30-16 at around 8:20pm, Unit 2 was southbound on SR4 (Dixie Hwy) in the right through lane. Unit 1 was stopped northbound on Dixie Hwy in the unidirectional left turn lane. Unit 1 struck Unit 2 while attempting to make a left turn into the private property drive of 7371 Dixie Hwy.

The driver of Unit 1 spoke to the driver of Unit 2 but then fled the scene without providing any information.
