

Narrative

On 10/14/2016 at about 4:31 P.M. Unit 1 was traveling westbound on Mack Rd. at approximately 25 m.p.h. and when near Fairview Hill Ct. failed to stop within the assured clear distance ahead and collided with Unit 2 which was also westbound on Mack Rd. and was stopped in traffic near Fairview Hill Ct. Unit 2 then collided into Unit 3 and Unit 3 collided into Unit 4. All units were westbound on Mack Rd. near Fairview Hill Ct. This was all a result from Unit 1 colliding into Unit 2.



