
Narrative

On 10-25-16 at about 6:41 am unit 2 was eastbound on Port Union Road though the intersection of Seward Road when unit 1 turned left in front of it. Unit 2 struck unit 1 and veered to the right and struck unit 3, which was sitting on northbound Seward Road.

Driver of unit 1 said his light was red and he was clearing the intersection when he turned.

Driver of unit 2 said her light turned yellow as she entered the intersection.

Driver of unit 3 said his light was red and the light for Port Union was green when the crash occurred.


