

**Narrative**

On 09/02/2016 at about 9:10 P.M. Unit 1 was traveling westbound Donald Dr. and when at 240 Donald Dr. Unit 1 went off the right side of the roadway and sideswiped Unit 2. Unit 1 continued straight and sideswiped Unit 3 and then finally came to rest when collided with Unit 4. The impact from Unit 1 into Unit 4 caused Unit 4 to bump Unit 5. Unit 5 did not report any damage.

The driver of Unit 1 was also charged with Failure to Control 331.34A


