

On 09/02/16 at 2:04 P.M. While backing up (in an east bound direction in the parking lot of Super America, 4511 Pleasant Ave.), Unit 1 (a hit/skip unit) struck unit 2 in the drivers side quarter panel. After striking Unit 2, Unit 1 drove away as a hit skip vehicle.

On 09/06/16 at 2:30 P.M. I responded to Super America on a report of a hit/skip crash. Upon arrival I was advised by the owner of Unit 2 that the crash was recorded on the security cameras of Super America. A Super America employee played the video feed of the hit/skip. I observed Unit 1 (a dark colored vehicle possibly a Nissan or Toyota product) backup and strike Unit 2. Unit 1 then drove away off camera in a southbound direction. From the video cameras I could tell the driver was a white male person between 40 and 50 years old. He appeared to be about 6 feet tall and weighed approximately 250 lbs. He was wearing jeans and a light colored shirt. The video was of a poor quality and nothing else could be observed on the video. A copy of the video was placed with records.
