
**Narrative**

On 9/3/2016 at 5:00 p.m. Unit 1 was southbound on Winton Rd. attempting to make a left turn onto Mack Rd. Unit 2 was northbound on Winton Rd. traveling through the intersection. Unit 3 was facing west at Mack Rd. in the right turn lane. Unit 1 turned in front of Unit 2 causing Unit 2 to strike Unit 1 which caused Unit 1 to strike Unit 3.

Unit 1 stated that he was in the middle of the intersection and attempted to clear the intersection after the light turned red.

Unit 2 stated that she was going straight through the intersection and went through the light while it was yellow.

There were no independent witnesses and we were unable to determine which unit was at fault.
