

Narrative

On 9/8/2016 at about 6:50 p.m. Unit 3 was stopped in traffic southbound on Pleasant Ave. near Augusta Blvd. Unit 2 was slowing at about 15 m.p.h. Southbound on Pleasant Ave. near Augusta Blvd. Unit 1 was traveling south on Pleasant Ave. at about 35 m.p.h. and failed to stop within the assured clear distance ahead and collided into Unit 2 pushing Unit 2 into the rear of Unit 3. Brake Lights on Unit 2 were inspected and found to be working properly.

Unit 1 was issued a citation for ACDA.
