

Narrative

On 9-26-16 at about 5:36 p.m. Units 1, 2 and 3 were westbound at 2326 Mack Rd. Unit 2 and 3 stopped with traffic. Unit 1 struck Unit 2 to the rear, causing Unit 2 to strike Unit 3 to the rear.

The operator of Unit 1 believed Unit 2 struck Unit 3 prior to her striking it. The operators of Units 2 and 3 did not agree with this and the operator of Unit 3 stated that she only felt one impact.
