

Narrative

On 09/27/2016 unit 1 was traveling eastbound on Mack Rd. at about 25 MPH when it failed to stop within the assured clear distance ahead, and in so doing, collided with unit 2 which was stopped in traffic on eastbound Mack Rd.

The driver of Unit 1, a black female, left the scene without stopping.

Unit 1 was a small silver vehicle with an unknown temporary license tag.


