## **2026 Sustainability Commission 1:1 Responses:**

**After 3 meetings, do you think the frequency of meetings (every other month; 6 per year) is appropriate?**

Mix of responses. The majority of Commission deemed every other month meeting frequency appropriate in conjunction with volunteer opportunities. The minority requested a monthly meeting frequency.

**After 3 meetings, are you interested in designating a formal “chairperson” and/or other officers to help run meetings? Do you see a need to draft bylaws?**

Consensus was there is no need for formal bylaws or officers. However, there is interest in electing “Embassadors” to serve as educators in the community on specific Sustainability topics (i.e., composting, orange hefty bag, etc.).

**What sustainability-related event, activity or meeting in 2025 did you enjoy most – and why?**

Discard Day, National Night Out, Groovin on the Green. Events that are most public interacting are more favored. Tabling at the City’s Farmers Market was requested.
